

# Finbro.Ph May Labor of Love Raffle Promo

### TERMS

# PROMO PERIOD

- 3. The Promo comprises of the following period:
  - a. "Loan application period" runs from May 1-30, 2023, both dates inclusive.

## PROMO ELIGIBILITY

  - a. is currently residing in the Philippines; and
  - b. has a registered account with at least one (1) "Approved loan" with Finbro website: <u>https://www.finbro.ph</u>, hereinafter referred to as "existing user".

  - b. A user who is not blacklisted or rejected for a loan
  - c. A user that qualifies as an eligible user as mentioned in the Promo Eligibility section.
